MINUTES

CALL TO ORDER

Vice President Tony Rogozinski brought the special meeting to order on Tuesday, June 10, 2008, at 6:30 p.m. Directors Justin Masters, Larry Brilliant, and Rob Vomund were in attendance. President Bill Vandegrift arrived at 6:35 pm. Also present were district employees Marni Francisco-Cady, Allison Hamaker, Dianna Hillyer, Sandi Kukkola, Wayne Lowery, Kent Oakley, Sherry Shannon, and five members of the public.

Motion No. 1 Director Masters moved and Director Rogozinski seconded the motion to approve the agenda. Motion carried 5-0.

John Everett, St. Andrews Village, presented the Board with questions regarding Landscape and Lighting Assessments Districts (L&Ls). Dianna Hillyer, Planning Director, answered most questions. Director Vandegrift explained this issue is being discussed at a future Parks and Planning Committee.
